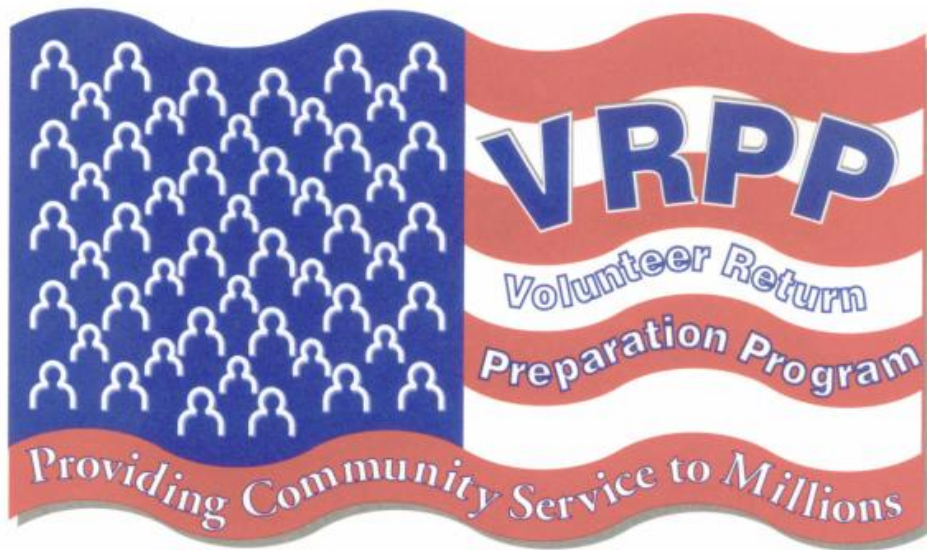

TEN-FOUR-ZERO, INC. will soon offer free tax preparation!

A Volunteer Income Tax Assistance (VITA) site needs a variety of dedicated individuals to provide tax assistance in an efficient and effective way.

To establish a core group of trained volunteers by January, integrated workshop training opportunities use the IRS provided "Link and Learn Taxes, the Volunteer Return Preparation Program (VRPP)" curriculum. The test requires volunteers to prepare two tax returns, perform a Quality Review, and then

answer 50 online questions. Each volunteer must successfully complete the test at an overall 70% proficiency to earn VRPP certification.
